An "underrated career"?



According to US News & World Report in January, librarianship is one of the excellent career choices for 2006! And yet, it is called "an underrated career." I think we've seen unfortunate evidence of this close to home in various ways. Recently, our secretary Lynne Gehrke asked her fellow LLAW members via

the listserv for material to justify making a law firm librarian position full time. This got me thinking - what would MY firm do if my hours were cut back to part time? Another thought: how HAVE they managed already at times when I haven't been available?

I took a medical leave a few years ago, and received a "get well" card from my firm's Milwaukee office staff. On the outside it said, "we wish you a speedy recovery so you can get back to the office and do your job ... " and on the inside it said, "...of course, we can't figure out just what it is that you do!" Obviously, there are a few different ways to read that statement -- but I thought, gosh, it's rather true: they really don't know just what I do! No one else at the firm could really substitute for me, could they?! A librarian is pretty important! It's unfortunate that so often the librarian/library staff positions are seen as "gravy" positions, and not as real STAPLES in an organization.

If you ever have the time and haven't done something similar already, I propose a little exercise: imagine what your organization would do if you disappeared for, say, just a couple of weeks. Write down what you come up with. It will probably make you smile, when you think of the people you work for trying to "do just what it is

that you do." Come up with some amusing anecdotes. Consider using some of this material tactfully at your next review. Please feel free to share your lists or stories with me; we can use a good compilation of "just what it is librarians do" as a resource for our members. And if you don't do this already, start saving those little messages of praise that people may email you every once in a while when you've helped them out. Even if you don't ever go public with them, you can look them over every so often when you're feeling cranky, on the job or off. Yes, I do this! Maybe it is goofy, but hey - it DOES help a bad mood! And it reminds me of what I bring to my organization.

It's the Information Age: the need for information pervades our society and our work. Information sources and services are continually in a state of flux. The librarian is THE person in the organization to keep on top (Continued on page 3)

LLAW Salutes 2006 Law Librarian "Unsung Heroes"

"Lawyers and judges in Wisconsin do terrific work. But where would they be without the members of their support staff who, behind the scenes, quietly make it all happen?" This, according to Ann E. Richmond, Publisher of the Wisconsin Law Journal,* is the question she and her staff asked themselves earlier this year after their annual Leaders in the Law event at which they honor Wisconsin's top attorneys. It prompted them to organize another event to recognize paralegals, legal secretaries, law librarians, firm administrators, court clerks - the "unsung heroes" of Wisconsin's legal community.

AALL 2006: An LLAW Grant Recipient's Experience

It had been four years since I last attended an AALL annual meeting, so I was very excited about going to St. Louis this past July to reconnect with colleagues from around the country and take part in the celebration of AALL's centennial conference. My sincere thanks to LLAW for helping me get there by awarding me a grant to help cover registration, travel and lodging expenses.

I'm a member of the State, Court & County Law Libraries (SCCLL) Special Interest Section, which held several events and activities during the conference. First up for me was the SCCLL Committee Chairs meeting, at which I heard reports on the work of all the committees and learned more about my duties as the incoming chair of the Education Committee. It was just in time, because a couple days later I would be leading the Ed. Committee meeting in the outgoing chair's absence. Jane Colwin and I both attended the Sunday morning SCCLL breakfast and business meeting, where we saw Marcia Koslov, former Wis. State Law Librarian, and Betsy Vipperman, former WSLL Reference & Outreach Services Librarian. Marcia is now the director of the Los Angeles County Law Library, and Betsy is Senior Librarian for Public Services at the New York Appellate Division Law Library in Rochester.

Another SCCLL highlight was the Tuesday evening reception on the 28th floor of the Thomas F. Eagleton U.S. Courthouse, located just a few blocks from the convention center. Completed in 2000, the facility is the home of the 8th Circuit U.S. Court of Appeals and the E.D. Missouri District and Bankruptcy Courts. Guests were treated to tours of both court and law library spaces, and delicious hors d'oeuvres courtesy of Thomson-West. Perhaps the most unique thing about the 8th Circuit law library is that it provides a nearly perfect view of the field at neighboring Busch Stadium. Who needs season tickets?! From there I made it back to the convention center just in time for the AALL Centennial Variety Show, where the standing room only crowd was treated to truly creative skits, songs, and parodies that had us rolling in the aisles. I saw a couple LLAW members on stage that evening; hats off to you!



Over 70 substantive programs were presented at the conference, and I attended as many as I could. From collaborative efforts to improve access to legal information for pro se litigants, to new and evolving ways of using handheld devices in law libraries, to learning about compassion fatigue and how to prevent it, there was literally something for everyone. For nearly every program I attended, my notes include a new idea to try or a different way to approach something we're working on here at WSLL.


Another interesting session I attended was a joint roundtable on library service to pro se patrons and prisoners, sponsored by three AALL Special Interest Sections: Social Responsibilities, Research Instruction & Patron Services, and Legal Information Services to the Public. The 45 people who attended shared their experiences and strategies in assisting and dealing with the expectations of self-represented litigants. Suggestions included giving them choices (eg., you can read this--or not; you can get an attorney, do it yourself, or do nothing); and listening empathetically, which is sometimes all they need or want and often helps them figure out exactly what their question is. Following that discussion, Barbara Golden, Minnesota State Law Librarian, described her library's Law Library Service to Prisoners (LLSP) program, which began in 1984. LLSP librarians visit inmates in each of the eight Minnesota primary adult correctional facilities at least once a month to assist them with research, and they maintain core legal collections in the prison libraries. In 2004, they made 120 prison visits and served 1,776 inmates.

Both plenary sessions of the conference were excellent. Linda Greenhouse, Pulitzer Prize-winning U.S. Supreme Court correspondent for <u>The New York Times</u>, gave a fascinating account of researching and writing her new book,

<u>Becoming Justice Blackmun: Harry Blackmun's Supreme Court Journey</u>. As the first print news reporter to have access to Blackmun's extensive archive and private and public papers, Greenhouse had the daunting task of sifting through the nearly 500,000 documents in the collection; the finding aid alone is over 300 pages long. Bob Berring, law professor at UC-Berkeley and legal research "guru," gave a centennial tribute, "Pioneering Change by Remembering Pioneers." In looking at where we've been and where we're going as a profession, he used several quotes, including one by Isaiah Berlin, "The fox knows many things; the hedgehog knows one big thing." Berring said that while gathering information used to be the one big thing librarians knew, the focus now is on guaranteeing authenticity of information. He suggested that in this age of foxes, law librarianship is a hedgehog. The one big thing we know is how to guarantee high quality information to anyone who needs it, and the role of librarians should be to ensure that information is permanent, authentic and accessible.

I also made several visits to the exhibits area, where opportunities abounded for learning about the latest new Lexis and Westlaw features as well as many other legal research products and services. I didn't win anything in the daily AALL prize drawings, but I did come home with a couple free books, some pens and other goodies to replenish my National Library Week prize bag, and my favorite item, distributed by the Houston Area Law Librarians: a red wooden ruler emblazoned with the words "Librarians Rule!" Need I say more?


