### **AALL Annual Meeting**

I was fortunate to be awarded a grant from LLAW to attend the AALL Annual Meeting in Philadelphia, July 23-26, 2011.

Many of you know that I love to travel whether it is for the library, the Navy or on vacation. I enjoy exploring new places, meeting different people and trying local delicacies.

While traveling, I often play games to entertain myself. One of my regular travel games is to ponder the thought, "If I were not a librarian what would I do for a living?" I have pretty much eliminated most airport jobs such as being an airline ticket agent, working for the TSA, being a part of the airport ground crew, etc. There are a few jobs I've considered, one being a flight attendant but that was when I was 12 and had never flown. # **AALL Announcements**

### AALL2go Pick of the Month

AALL's Continuing Professional Education Committee presents the AALL2go pick of the month: <u>Teaching and Using Legal Classics</u>: <u>Black Letter Law and the Google Generation</u>.

This hour-long audio file recorded at the 2007 Northeast Regional Law Libraries Meeting in Toronto features two speakers who are actively involved in teaching legal research. Both speakers try to give the audience a sense of how law students may expect to obtain easy answers to legal issues because they are used to finding "the answer" using Google and other technology, yet the black letter law may be more difficult to find...if it even exists.

Shelley W. Obal, a research partner at Toronto law firm Osler, Hoskin & Harcourt LLP, focuses on legal research using expert resources in a law firm setting and tells her law students and new attorneys to begin research with secondary sources before moving online for primary sources.

Next Alison Harvison Young, judge on the Superior Court of Justice of Ontario and former law dean at Queen's University, uses her experiences in academia and on the bench to provide examples of real world research skills in practice, both good and bad. She also briefly describes the civil law versus common law systems and how the research methods in each system may be a bit different.

The remainder of the program contains a question and answer session hosted by moderator John Sadler from the University of Western Ontario law library.

### Before they were Librarians...





Inside the Reading Terminal Market – the produce shop (above) and an Amish bakery (below) keep workers busy.






The Assembly Room in Independence Hall -- this is where the Second Continental Congress adopted the Declaration of Independence.



(Above) "Don't block the box!" was a 1980s campaign to end grid-lock in New York City. Drivers were reminded that "blocking the box" (an intersection, usually with white lines painted across it) would result in a fine and points on a license. This effort has spread to Philadelphia and some other east coast cities.

(Right) Philadelphia's Hard Rock Café at 12<sup>th</sup> and Market Streets. Among motorists in Philly, there seems to be a habit (tradition?) of sounding one's horn as soon as the traffic light turns green.






In addition to murals, Philadelphia's impressive public arts tradition includes several sculptures. The JFK Plaza features Robert Indiana's famous LOVE sculpture.

Outside the Municipal Services Building is Your Move, a series of game pieces from Monopoly, Parcheesi, checkers and dominoes.



China Wedge is a 40-foot long sculpture comprised of 22,000 Chinese cups, bowls and spoons wedged into a space under an escalator, by Mei-Ling Hom.
