

Atalay, Melis. "Regulating the Unregulable: Finding the Proper Scope for Legislation to Combat Copyright Infringement on the Internet." <u>Hastings Communications and Entertainment Law Journal (Comm/Ent)</u> 36:167-191 (winter 2014)

The author examines recent Congressional failures to pass legislation that would regulate digital technologies in order to protect copyright. He suggests that future bill drafters collaborate with experts who are able to research the concrete effects of online piracy, determine the proper scope of a solution, and find technology that would work without destroying the Internet's open nature.

Balganesh, Shyamkrishna. "The Uneasy Case Against Copyright Trolls." <u>Southern California Law Review</u> 86:723-781 (May 2013)

Copyright trolling refers to the practice of acquiring an interest in a copyrighted work with the sole objective of enforcing claims relating to that work against copiers. This article suggests that a rule requiring examination of the incentives and motives of copyright infringement claimants could put a stop to trolling.

"Copyright Exceptions for Libraries in the Digital Age: Section 108 Reform." <u>Columbia Journal of Law & the Arts</u> 36:527-606 (summer 2013)

This symposium issue comprises four panel sessions: 1) The legal landscape, 2) Section 108 issues other than mass digitization, 3) To what extent libraries should be permitted to engage in mass digitization of published works, and 4) What the conditions should be for libraries digitizing, maintaining and making available copyrighted works.

Damich, Edward J. "Our Copyright Code: Continue Patching or Start Rewriting?" <u>University of Miami Law Review</u> 68:361-384 (winter 2014)

The author hopes to provoke discussion on the need for Copyright Act revision by highlighting issues raised by some recent cases involving digital technology, and by identifying some lingering problems: fair use, orphan works, and the status of the Copyright Office.

Evans, Tonya M. "Safe Harbor for the Innocent Infringer in the Digital Age." Willamette Law Review 50:1-42 (fall 2013)

The author proposes that the safe harbor provisions for copyright infringement by online service providers, provided in Title II of the Digital Millennium Copyright Act, be extended to end users as well. She concludes with concrete examples of how a safe harbor for users could be applied to activities in which accidental and good faith infringers might engage.

Garcia, Michelle. "Browsewrap: A Unique Solution to the Slippery Slope of the Clickwrap Conundrum." <u>Campbell Law</u> <u>Review</u> 36:31-74 (fall 2013)

This article explores the current landscape of end-user license agreements, traces the recent controversies of Shrinkwrap and Clickwrap licensing, and proposes a new avenue of regulation via federal copyright law.

Hunter, Ian. "Free Legal and Official Information on the Web: Is It time to Stop Google-Bashing?" <u>Legal Information</u> <u>Management</u> 13:256-259 (2013) The starting point for this article came while the author was looking for examples of why a Google search was not a substitute for going directly to a commercial database or an authoritative website. He found these examples more and more difficult to find; in most cases it seemed Google *was* finding the answers.

Rasmus, Daniel W. "Uncertainty and the Future of Libraries." Computers in Libraries 33(10):4-7, 32 (December 2013)

In the discipline called scenario planning, uncertainty drives exploration of what might be. The author discusses eleven items that he believes reflect the most important issues that are likely to reshape libraries, and urges libraries to be prepared to respond rapidly when uncertainties start to become clear.

Walker, Robert Kirk. "Negotiating the Unknown: A Compulsory Licensing Solution to the Orphan Works Problem." <u>Cardozo Law Review</u> 35:983-1018 (February 2014)

If the owner of a work's copyright is unknown or cannot be located, then the work cannot be digitized. The Copyright Office has proposed a statutory limitation on infringement liability for those who have completed a "reasonably diligent" search for the work's owner, but this article argues that a compulsory licensing system is needed as well.

Woan, Tansy. "Searching for an Answer: Can Google Legally Manipulate Search Engine Results?" <u>University of</u> <u>Pennsylvania Journal of Business Law</u> 16:294-332 (fall 2013)

This comment argues that, even assuming that Google prioritizes its own websites in search results, this practice does not violate federal antitrust laws, and that any attempt to regulate the ranking of Google search results would violate the First Amendment.

Zillman, Marcus P. "Knowledge Discovery Resources 2014 - An Internet Annotated Link Dataset Compilation." <u>LLRX</u> (January 26, 2014) <u>http://www.llrx.com/features/knowledgediscovery2014.htm</u>
