


#### Before they were Librarians...

What shaped us into the librarians we are today? For many members, LLAW may be the first professional organization to which they've belonged. Others, however, became librarians after having worn other hats throughout their lives. Over the next year, we'll meet some of our members who have made law librarianship their second or even third career.

After having graduated from law school at UW in 1980, Barbara Fritschel served five years in the JAG office as a Captain in the Air Force where she spent most of her years in Korea and England helping military personnel to resolve domestic issues. She then left the practice of law and enrolled at the Wartburg Seminary in Dubuque, Iowa, an institution her great grandfather had helped to found.



Barbara took over the U.S. Court of Appeals Seventh Circuit branch library in Milwaukee in 2006. She had received her MLIS from the University of Washington and after serving as a librarian at the Fifth Circuit in Beaumont, Texas, for 14 years, she decided "after one too many hurricanes" she'd prefer to return to Wisconsin to be closer to her mother. In her third career Barbara assists judges, law clerks, interns and attorneys with research. ## AALL2go Pick of the Month

AALL's Continuing Professional Education Committee presents the AALL2go pick of the month: <u>Why Don't I Get Easy</u> <u>Questions Anymore?: The Changing Nature of Reference and Patron Services</u>.

This one-hour MP3 recording features **Kay Samuels** as the moderator and **Joan Shear** and **Jeanette Bosschart** as speakers. During the program the speakers discuss how they receive fewer easy reference questions than in the past but that the questions they get are of a different nature. Reference questions can cross practice areas, deal with complex procedural issues, or include foreign law. Reference questions are also harder because researchers ask more "raw, undigested" questions. These are questions the researcher has not thought out and therefore cannot provide structure or context for. Both also note that there are some new "easy" reference questions, which have to do with patrons doing research using online sources, such as "Why can't I find this law review in Westlaw or Lexis?" when the patron is in a case law database. Easy user questions are now more about the limitations of online database content.

Both speakers also acknowledge that patrons' expectations have changed. Researchers expect results quickly, in full-text, and in electronic format. If the research involves foreign law there is also an expectation that the information will be in English. Finally, both note that researchers do not have any expectations regarding quality or authority of the results they find.

The discussion ends with a look at how technology has taken researchers out of the library and the challenges both speakers' libraries face in trying to reach the patrons who need them. Both commented on the technological challenges of the reference interview challenges when the interaction is not face-to-face and certain cues that were evident now have to be extracted through an online interaction. The program ends with members of the audience providing comments or asking questions of the speakers.

### **Government Relations**

In the fall of 2010, a legislative study committee was formed to review how and by whom circuit court records may be accessed through the Wisconsin Circuit Court Access database. <u>The Special Committee on Review of Record Access of Circuit Court Documents</u> held meetings in September, November and December of 2010.

On March 9, 2011, Representative Ed Brooks, chair of the special committee, sent a <u>memorandum providing a "final up-date</u>", deciding not to reconvene the committee for any additional meetings. Rather, he explains "in light of my own views on the study committee's charge, my prerogatives as chair, and my sense that the committee had thoroughly discussed the matters that I am interested in forwarding to the Joint Legislative Council, I directed staff to develop a bill draft". <u>WLC:0102/1</u> concerns expungement of court records and states in the prefatory notes that current law does not "define what it means to expunge a court record" or "articulate whether an expunged record can be considered in employment in housing matters".

#### **Government Relations (continued)**

Expunction is also the focus of Rules Petition 09-07 before the Wisconsin Supreme Court. Open Conference was held in October 2010 on this petition along with 05-01 relating to cost assessment in the lawyer regulation system, 10-07 concerning the Lawyers Assistance Corporation, and 09-09 diploma privilege. Final orders were released for 09-09 and for 10-07 in November and October respectively.

With the 2011-2013 proposed state biennium budget, focus turned to several changes affecting public libraries. The spring 2011 months would see the future budget for BadgerLink cut by 10% (with \$512,000 later restored by Joint Finance) and 10% cuts for public library systems, statewide contracts service contracts such as WiLS, and cuts to the Talking Book and Braille Library (with \$183,400 later restored by Joint Finance). Possibly the biggest impact is cuts to maintenance of effort, which is slated for elimination. The Joint Finance Committee concluded meeting during the early hours of Saturday, June 4<sup>th</sup>; the proposed budget is now with the full legislature.

AALL asked law librarians throughout the nation to organize state working groups to develop a national inventory of primary legal resources from every level of government, in the interest of authenticating and preserving these sources. Patricia Cervenka, Professor of Law and Director, Marquette University Law Library, is leading Wisconsin's efforts; staff members of the Marquette University Law Library and the Wisconsin State Law Library are contributing to the inventory.

# Sept. 8, 2010, *From Library Stacks to Baghdad, Iraq: Experiences in the Iraqi Courts*, Imperial Garden East, Madison (27 registrants)

Julie Tessmer, Deputy Law Librarian, Wisconsin State Law Librarian gave us a glimpse into her time serving as a Legalman Senior Chief Petty Officer for the Reserves. She worked for an Airforce JAG, who was the Liaison Officer to the Central Criminal Court of Iraq (CCI). CCI is an Iraqi Court with national jurisdiction which focuses on cases involving terrorism. Julie was involved in obtaining arrest warrants and detention orders and working cases through the investigative hearing process. She found this work to be challenging, rewarding and a bit frightening at times. Julie is hopeful for the continued development of an equitable justice system in Iraq.

#### Nov. 30, 2010, The Matrix 2011: Tracking Legislation Using Bar Codes, Hi-Way Harry's, Johnson Creek (29 registrants)

Steve Miller, Chief of the Legislative Reference Bureau demonstrated the use of bar and matrix codes in tracking legislation. Bar codes are currently used by several states to track legislation. Wisconsin will be the first state to use the information-dense matrix codes for this purpose.

# Feb. 22, 2011, *Teaching Law Students How to Research*, Godfrey & Kahn Madison & Milwaukee offices via videoconference (42 registrants)

As a follow-up to the May 2010 meeting where law firm librarians discussed associate training in firms, LLAW member Julie Norton, Reference Services Coordinator and Student Services Librarian, Marquette University and Ursula Weigold, Director of Legal Research and Writing and Clinical Associate Professor of Law, UW-Madison, discussed how they teach law students to research.

# April 14, 2011, *Information Ethics & WikiLeaks*, Swig, Milwaukee – Joint Meeting with the Wisconsin Chapter of SLA (24 LLAW registrants, 41 total including SLA members)

Michel Zimmer, Ph.D, Associate Professor, UW-Milwaukee, SOIS and Co-Director, Center for Information Policy Research, talked about the complex array of ethical issues related to the WikiLeaks phenomenon, including the interplay of core issues in information ethics such as openness, transparency, freedom from bias, intellectual freedom as well as security, privacy and professional responsibility. He also discussed the ethical dilemma faced by librarians in the face of WikiLeaks.

### Treasurer

We started the 2011 Fiscal Year with a total of \$8,564.80 including checking and savings and ended the year with a total of \$9,571.45 including checking and savings for an overall gain of \$1,006.65. The Grants Committee budgeted \$2,400 and awarded \$2,200 in grants for the year (the check for one of the grants for \$800 was cut in FY12). The Chapter conducted a very successful Educational Institute in October 2011. The revenue was \$8,929 and the expenses were \$8,529.91 for a profit of \$399.09. (The Educational Institute revenues and expenses are included under Programming.) We gained \$1,832 in revenue for membership dues. The quarterly meetings made a profit of \$211.45. The Public Access to Legal Information Committee gave LLAW their royalty check from William S. Hein & Co. for \$130.76 for Legal Research in Wisconsin. The Public Relations Committee budgeted \$200 and spent \$97 on materials and shipping for the display at the AALL Annual Meeting. Operating costs were \$73.21 for the Wisconsin Nonstock Corporation Annual Report (\$10) and miscellaneous gifts in connection with illness.
